



### STRATEGIC GOALS

THE IMCC BOARD UNDERTOOK A STRATEGIC PLANNING PROCESS AS A PART OF ITS ANNUAL RETREAT IN 21-22. THE FOLLOWING 3-YEAR GOALS WERE IDENTIFIED:

**1.Grow the membership** of the Sangha, focusing on recruiting from diverse communities (racial, geographical, age, economic) to provide continued relevance and reflect our larger community. Also, a.Increase the array of practice opportunities b.Expand leadership opportunities within the Sangha by developing and refining roles: look to other IMC in US for models that we could copy/adapt. c.Partner with other studios, meditation groups and retreat centers to extend reach, coordinate offerings and outreach to raise awareness. d.Outline our welcome process to encourage visitors to engage (and invite again). 2.Create a financial plan that provides room for growth of sangha, with goals and tactics. 3.Outline a technology roadmap that explores and reports the benefits / downsides of use for long term health of sangha.
